FALL FIELD OF INTEREST GRANTS AWARDED

The **Alex Workman Memorial Fund** has awarded two grants that will impact students in Rush County who are affected by Autism. The first grant will fund a request for the Elementary Life Skills class at RES West, taught by Nicole Reiner. The purchase of 3 Carousel Spinning Chairs and 3 Rock Around seats will help the students build core strength, balance, and coordination and encourage them to build strength. The second grant will completely fund a movement course for RES West students. This course, planned by teacher Anna Jo Richards, will provide the opportunity for movement for students to get their frustrations out, take a break before they become overwhelmed, and get some much needed sensory input.

The **Youth Athletic Fund** awarded the **LionStrong** program (a joint venture between RMH and RCHS) funding to continue the purchase of supplies for healthy snacks to accompany a nutrition lesson aimed toward high school athletes and other students who attend the study tables after school on Wednesdays. The goal is to provide knowledge of the needs
