A Gift from Your RMD Can Benefit You Today and Rush County Forever

The CARES Act suspended required minimum distributions (RMD) from IRAs in 2020. However, IRA owners age 72 and older will resume their RMD in 2021.

Looking for a simple way to make a positive difference for Rush County? Consider making a gift with your RMD or other charitable distribution from your IRA. For donors at least 70 ½, a gift made through your IRA's plan advisor directly to RCCF is not taxed as income. You may give up to \$100,000 per year and make an impact forever.
